Tuesday, June 9, 2020  
9:30 a.m.**

The public hearing for Petitions for outlet to CD1 of the Stevens County Board of Commissioners was called to order at 9:30 a.m., Tuesday, June 9, 2020, by Chair Bob Kopitzke. Members present were Wiese, Ennen, Kopitzke, Wohlers, and Staples. Others in attendance were Scott Erickson, Stephanie Buss, Don Sperr and Herb Nelson.

Chair Kopitzke called the hearing to order at 9:30 a.m.

The Pledge of Allegiance was recited.

The agenda was approved on a motion by Wiese, second by Ennen, and all members voting aye,

Having no public comment, Scott Erickson Ditch Inspector reviewed the Five Petitions for outlets to CD1. Petitions are from Herb Nelson, Don Sperr, Paul Daly, Keith Stahn and Curt Stahn. Erickson presented map outlining drainage into system for all petitions. Erickson fielded questions from the commissioners.

Stephanie Buss Auditor Treasurer noted for the record that the petitioners will be responsible for all cost related fees for the petition hearing.

Commissioner Staples motioned to approve Findings and Fact for Herb Nelson for outlet fee of \$210 for CD1, \$70 per acre for 14 benefiting acres. Commissioner Ennen seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for Karen Daly for outlet fee of \$540 for CD1, \$70 per acre for 18 benefiting acres and \$60 per acre for 18 benefiting acres. Commissioner Wohlers seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for Don Sperr for outlet fee of \$360 for CD1, \$80 per acre for 24 benefiting acres. Commissioner Wohlers seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for Don Sperr for outlet fee of \$645 for CD1, \$70 per acre for 43 benefiting acres. Commissioner Ennen seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for don Sperr for outlet fee of \$135 for CD1, \$80 per acre for 9 benefiting acres. Commissioner Wiese seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for Curtis Stahn for outlet fee of \$525 for CD1, \$80 per acre for 35 benefiting acres. Commissioner Wiese seconded the motion and all members voting aye, motion carried.

Commissioner Staples motioned to approve Findings and Fact for Keith Stahn Trust for outlet fee of \$150 for CD1, \$80 per acre for 10 benefiting acres. Commissioner Wiese seconded the motion and all members voting aye, motion carried.

Having no further business, the meeting was adjourned at 9:55 a.m. on a motion by Staples, second by Wohlers and all members voting aye.
